



The Master may invite any member of the Lodge as special invitee to participate in the debate of the Standing Committee but such invitee shall have no power to vote.	By-Law No.6(ii)  The Standing Committee shall consist of the Worshipful Master, Immediate Past Master, Wardens, Treasurer, Secretary, Director of Ceremonies and Two Members elected in the Lodge in April after the Installation.
