IV Admission and retirement of members (clause VIII)	No candidate shall be initiated and no Brother shall be admitted as the member of the Lodge, if on ballot, two or more Black balls appear against him	No candidate shall be initiated and no Brother shall be admitted as the member of the Lodge, if on ballot, simple majority of members appear and vote against him

V Subscription and fees (clause XVII)	The admission fee for rejoining members shall be Rs.500 and shall be payable in advance	The admission fee for rejoining members shall be Rs. 1000 and shall be payable in advance

VI Elections (clause XIX)	The master and the tyler chosen shall be elected at a regular meeting in December and the master shall be installed at the next regular meeting in February	The master and treasurer elected, and the tyler chosen, shall be elected at a regular meeting in December and the master shall be installed at the next regular meeting in February
VIII General (clause XXVIII)	A sum of Rs. 50 from the general fund of the Lodge shall be annually placed at the disposal of the master to meet emergent cases of distress. In case the master exercises this privilege, he shall report the circumstances at the next regular meeting of the Lodge. Otherwise, the sum shall, at the close of the year, be carried to the charity fund.	The financial year for the accounts shall be 1 February to 31 January
VIII General (clause XXX)	A sum of Rs. 125 from the general fund of the lodge shall be paid to the secretary as impressed cash to meet petty expenses and shall be reimbursed by the treasurer on the secretary rendering to him the accounts of such expenses	Secretary can be reimbursed of actual expenses incurred by the treasurer subject to approval from the audit committee.
