



1. Page 2. Bye-Laws 4a : ACTIVE MEMBERS shall be those who permanently reside within sixteen kilometers radius of Hyderabad and Secunderabad. Resident members who may be invalid, infirm or otherwise unable to attend the Meetings of the Lodge may on application be placed on Absent list with the approval of the Lodge.	ACTIVE MEMBERS shall be those who permanently reside within limits of Greater Hyderabad Municipal Corporation (GHMC). Resident members who may be invalid, infirm or otherwise unable to attend the Meetings of the Lodge may on application be placed on Absent list with the approval of the Lodge.

The object of this fund is to provide refreshments to Members, Visitors and Lodge Guests at the Meetings. A sum of Rs. 90/- out of the monthly Subscription of Resident Member and Rs. 120/- per year out of the Annual Subscription of Absentee Members will be credited to this fund.																																																												






