Existing By-Laws	Amended By-Laws
<p><b>By-Law No. 10-Subscription:</b></p> <p>The Subscription for Resident Member shall be Rs.480/- per year and for Absent Member Rs.360/- per year. If Absent Member resides within the limits of the Lodge for more than two months continuously, he shall be charged the Residents' subscription from the second month onwards. If any member allows his subscription to remain unpaid for six months or more, he shall be deprived of, while so in default, of the rights of voting, of being appointed or elected or continuing in any office in the Lodge and proposing, seconding or speaking on propositions before the Lodge, such defaulting member shall also be liable to be excluded under 156 of B of C of GLI (Cessation and Exclusion from Membership will be Governed by rules 124 and 156 of the B of C of GLI)</p>	<p><b>By-Law No. 10-Subscription:</b></p> <p>The Subscription for Resident as well as Non-resident Member shall be Rs.520/- per year. In addition, the actuals payable to GLI and RGL of SI shall be collected along with the subscription fees. If any member allows his subscription to remain unpaid for six months or more, he shall be deprived of, while so in default, of the rights of voting, of being appointed or elected or continuing in any office in the Lodge and proposing, seconding or speaking on propositions before the Lodge, such defaulting members shall also be liable to be excluded under 156 of B of C of GLI (Cessation and Exclusion from Membership will be Governed by Rules 124 and 156 of the B of C of GLI.)</p>
<p><b>Bye-Law No. 8(a)-Funds: Benevolent Fund</b></p> <p>A contribution of Rs.10/- shall be paid by every member in a year at the beginning of the year. &amp; Other Voluntary contributions that may be made in special occasions shall also be credited to the Benevolent Fund.</p>	<p><b>Bye-Law No. 8(a)-Funds: Benevolent Fund</b></p> <p>A contribution of Rs.100/- shall be paid by every Subscribing member once a year, along with the Subscription fees. A separate Benevolent Fund Account is maintained in the Bank. The fund is exclusively utilized for the benefit of its members &amp; in times of distress. Other Voluntary contributions that may be made on special occasions shall also be credited to the Benevolent Fund.</p>
