

By-Laws
of
Hiram Lodge of Mark Master Masons
No. 4 G. M. I. (No. 82 E. C.) Bangalore.

MEMBERS

1. The Lodge shall consist of Resident and Non-Resident Members.

(a) Resident : Members are those who are residing within a radius of 15 miles from the limits of Bangalore Corporation.

(b) Non-Resident : Members are those who are not residing within the area stated above.

DAY OF MEETING

2. The Regular Meeting shall be held on the second Friday in the months of January, April, July and October at Freemasons' Hall, Bangalore.

ELECTION

3. The Annual Election of the Master, Treasurer and Tyler shall be held on the day of the Regular Meeting in the month of July.

INSTALLATION

4. The Master elect shall be installed at the next Regular Meeting held in the month of October.

TREASURER

5. All payments exceeding Rs. 20/- shall ordinarily be paid by cheque only. The Lodge money shall be deposited in such Bank as the Lodge may from time to time direct. The Master and Treasurer shall jointly operate the account.

SECRETARY

6. The Secretary shall keep such books and make such entries as are prescribed under Rule 126

ARREARS

12. Any Member whose dues shall remain unpaid for a period of six months shall receive notice of the same from the Secretary and should they not be paid up within one month from the date of such notice the member shall be liable to be dealt with under Rule 147 of the Book of Constitutions for exclusion.

RESIGNATION

13. Any Brother wishing to resign shall intimate the same either by letter to the Secretary or in open Lodge.

EMERGENT MEETING

14. Should a Lodge of Emergency be summoned for the express purpose of advancing any Brother or Brethren each such Brother shall pay an additional fee of Rs. 10/-.

Treasurer and Secretary. The W. M. shall preside at such meetings and in his absence the next I. P. M., and in the absence of any of these the Warden senior in rank.

FEES FOR ADVANCEMENT AND JOINING

10. The fees to be paid for advancement including Grand Lodge Registry and Certificate and also for Joining shall be as follows :

11. The quarterly subscriptions shall be as follows :

Resident Member	...	Rs. 4/-
Non-Resident Members	...	Rs. 4/-

The Secretary shall not liable to pay any subscription.

REGISTRAR

7. The Registrar shall maintain the Register prescribed under Rule 140 of the Book of Constitutions.

TYLER

8. The Tyler shall be paid for his attendance at each meeting when held and for the Superintending the preparation of the Lodge Rooms, a fee of Rs. 5/-. It shall be Tyler's duty to keep the Tyler's Book and to see that all the Brethren who enter the Lodge sign their names in it, to examine carefully all visitors and to see that the Brethren are properly clothed and that the candidates are properly prepared.

PERMANENT COMMITTEE

9. The Permanent Committee shall consist of W. M. and other P. Ms., in the Lodge, Wardens,

ALTERATION OF BY-LAWS

It shall not be competent for the Brethren to abrogate, amend or alter these By-laws unless the abrogation shall have been duly proposed and passed at the Regular Meeting, after insertion in the summons and read and confirmed at the next Regular Meeting of the Lodge. The change shall not become effective until subsequently approved by the D. G. M., and M. W. G. M.
