
## PROPOSED AMENDMENT IN BY - LAW NO. 6

### Subscription: (By - law No. 6)

EXISTING	PROPOSED FOR AMENDMENT
Every member shall pay an annually membership of Rs. 250/-and a steward subscription of Rs. 150/-along with the actual GLI and RGL dues payable. The subscription shall be paid before June every year. Otherwise it will be treated as arrears. Further any change required in item 4 & 5 of this By-law may be effected after due recommendation by the permanent Committee and the same is included in the Agenda of the next regular meeting. Then a suitable resolution for amendment of by-law be moved in that regular meeting of the Lodge, be passed, approved and confirmed. It should be further approved by RW the Regional Grand Mark Master and MW the Grand Master of Grand Mark Master Masons of India for implementing the change.	Every member shall pay an annually membership of Rs. 250/-and a steward subscription of Rs. 640/-along with the actual GLI and RGL dues payable. The subscription shall be paid before June every year. Otherwise it will be treated as arrears.
