

43. Secretary, the Asst. Director of Ceremonies, the Inner Guard, the Almoner and any TWO Past Masters or Past Wardens duly elected by the Lodge at the Installation Meeting and any FIVE of the said Standing Committee shall form a quorum.


43. STANDING COMMITTEE: There shall be a committee styled the "Standing Committee" of the Lodge, which shall consist of the Worshipful Master, Immediate Past Master, Senior Warden, Junior Warden, Chaplain, Treasurer, Secretary, Director of Ceremonies, Senior Deacon, Junior Deacon, Asst. Secretary, Asst. Director of Ceremonies, Almoner, Inner Guard and all Past Masters of the Lodge and any FIVE of the said Standing Committee shall form a quorum, provided atleast two from amongst the WM, SW, JW, Treasurer and Secretary are present amongst the said FIVE Brethren.

The above amendments were regularly Proposed and Seconded in open Lodge at a regular Meeting held on 19.September.2014, Passed at the regular Meeting held on 17.October.2014 and confirmed at the regular Meeting held on 26.Nov.2014.


