
SUB:AMENDMENT TO BYE-LAWS OF RAM LODGE GOLDEN JUBILEE NO.148


a. The financial year of the R.A.M. Lodge shall be from June to May. The accounts of the Mark Lodge shall be closed on the last date of May every year.






