
SUB:AMENDMENT TO BYE-LAWS OF

EXISTING BYE LAW

IV. DUES AND FEES

6. The fees and subscriptions payable to the Lodge shall be as follows :

(a) Subscription for each year

- i) Of Resident Member - Rs.750/-
- ii) Of Out-station Member - Rs.700/-
- iii) Of Non-resident Member - Rs.400/-

The Members shall also pay such half-yearly / annual fees as are payable by the lodge for each of their subscribing Member to the Regional Grand Lodge of Southern India and Grand Lodge of India.

- iv) Life Member (one time subscription) - Rs.5000/-
- (b) Initiation Fee - Rs.2500/-
- (c) Joining Fee from Indian Constitution - Rs.1000/-
- (d) Joining Fee from other constitutions - Rs.2000/-
- (e) Re-joining Fee - Rs.1500/-
- (f) Installation Fee of Honour, payable by and devoted to Charity Fund of the Lodge
 - WM - Rs.250/-
 - SW - Rs.100/-
 - JW - Rs.100/-
- (g) Fee for an Emergency Meeting - Rs.150/-
- (h) Entrance Fee for Madurai Masonic Trust - Rs. 50/-
- (i) Annual Subscription for Madurai Masonic Trust - Rs. 50/-
- (j) All Members of the Lodge shall be members of the Madurai Masonic Trust and shall pay Entrance Fee (along with Initiation or Joining Fee) and also the annual subscription, both of which shall be considered as dues.

IV. DUES AND FEES

6. The fees and subscriptions payable to the Lodge shall be as follows :

(a) Subscription for each year

- i) Of Resident Member - Rs.1000/-
- ii) Of Out-station Member - Rs.950/-
- iii) Of Non-resident Member - Rs.950/-

The Members shall also pay such half-yearly / annual fees as are payable by the lodge for each of their subscribing Member to the Regional Grand Lodge of Southern India and Grand Lodge of India.

- iv) Life Member (one time subscription) - Rs.7500/-
- (b) Initiation Fee - Rs.5000/-
- (c) Joining Fee from Indian Constitution - Rs.1500/-
- (d) Joining Fee from other constitutions - Rs.2500/-
- (e) Re-joining Fee - Rs.2000/-
- (f) Installation Fee of Honour, payable by and devoted to Charity Fund of the Lodge
 - WM - Rs.1000/-
 - SW - Rs. 500/-
 - JW - Rs. 500/-
- (g) Fee for an Emergency Meeting - Rs.150/-
- (h) Entrance Fee for Madurai Masonic Trust - Rs. 50/-
- (i) Annual Subscription for Madurai Masonic Trust - Rs. 50/-
- (j) All Members of the Lodge shall be members of the Madurai Masonic Trust and shall pay Entrance Fee (along with Initiation or Joining Fee) and also the annual subscription, both of which shall be considered as dues.
