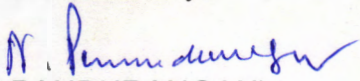

By-Law No: II/3, III/5, III/6, V/17, V/18 (a) II/3 the regular meeting of the Lodge shall be held at Free masons Hall, Vidyanagar, Kasaragod, on the first Saturday of every month at such hour as the master may, from time to time, direct. (b) III/5 The Annual subscription of a Resident Member shall be Rs. 1500/- and that of non-resident member is Rs. 1000/- payable on 1st January of every year in advance. (c) III/6 The following shall be Fees payable in advance:- Initiation- Rs. 500/- Joining- Rs. 200/- Joining from a Foreign Constitution- Rs. 150/- Rejoining- Rs. 100/- (d) V/17 At the regular meeting in December the Lodge shall appoint a standing committee consisting of Master, Immediate Past Master, Wardens, the Secretary, the Treasurer and two other members. (e) V/18 At the regular meeting in December the Lodge shall appoint the committee referred to in Rule 129 of the Book of Constitutions.	By-Law No: II/3, III/5, III/6, V/17, V/18 (a) II/3 the regular meeting of the Lodge shall be held at Free masons Hall, Vidyanagar, Kasaragod, on the first Thursday of every month at such hour as the master may, from time to time, direct. (c) III/6 The following shall be Fees payable in advance:- Initiation- Rs. 5000/- Joining- Rs. 4000/- Joining from a Foreign Constitution- Rs. 6000/- Rejoining- Rs. 6000/- (d) V/17 At the regular investiture meeting in January the Lodge shall appoint a standing committee consisting of Worshipful Master, Immediate Past Master, All Past Masters who occupied the Eastern Chair of Lodge Kasaragod for 12 complete months, having 50% or more attendance in the previous year in Lodge Kasaragod, Wardens, the Secretary, the Treasurer will be the members and two other members to be elected in investiture meeting in the month of January.
