

14.c. Donations made by any member with the specific proviso that they may be held in a specified name AND applied to a specified charity or charities only	14 c. Donations made by any member with the specific proviso that they may be held in a specified name AND applied to a specified charity or charities only. c.i. Brethren donating for specific proviso i.e. Retirement homes in DMS and Lodge donating for Retirement homes in DMS from its own funds or combination of both, the following terms, rules will be applied. c.ii. If single brother donates (amount equivalent to Donor category amount as prescribed by DMS) for a retirement unit, A tablet with the donor's name also mentioning in whose memory the donation was made, will be prominently displayed in front of the unit donated. The donor and his spouse throughout their lifetime can stay in the said home. c.iii. The brethren can donate to clause c.i. as per their might and Donors names will be displayed at an appropriate place on retirement homes. c.iv. Brethren who have donated 2 lacs and above for c.i. are eligible for allotment of Retirement homes of Lodge Deccan in DMS and it is allotted to the donors with Serialism. A separate register to be maintained with Donors and Spouse particulars, amount donated and terms and conditions.
24.c. If the elected Tyler be not a subscribing Member of the Lodge or be a serving brother, he may be paid a fee of not more than Rs 100 a month	24 c. If the elected Tyler be not a subscribing Member of the Lodge or be a serving brother, he may be paid a fee as per lodge resolution from time to time.
33b. None	33 b. Deccan Masonic Society : Lodge Deccan being affiliate Member of Deccan Masonic Society for having paid Rs 500000.00 affiliate Membership fee and One member of Lodge Deccan to be a Member of the Board of Management of DMS as per their By-law no.3. Lodge to elect one Member in the open Lodge to represent in the Board of DMS for a term of two years in the month of June. However he will join the Board on GB meeting.
33c. None	33 c. Lodge Deccan no 20 Charitable Trust : Four members of the Lodge shall be nominated to the trustees of Lodge Deccan No.20 Charitable Trust, besides Ex-officio Members. Every year two Brethren retire and in their place the Lodge to nominate two Brethren to the Lodge Deccan no 20 Charitable Trust at the installation Meeting in January. The retiring Brethren are eligible for reelection.
