

Existing By-Laws	Amended By-Laws
By-Law No. <u>11</u> <div>The annual Subscription shall be Rs.240.00 for every Companion payable in advance plus the annual dues payable to the Supreme Grand Chapter of India and the Regional Grand Chapter of Southern India respectively at the prevailing rates. Any companion allowing his subscription to remain Unpaid for more than six months shall be liable for exclusion under Rule 156 of Book of Constitution.</div>	By-Law No. <u>11</u> <div>The annual Subscription shall be Rs.440.00 for every Companion payable in advance plus the annual dues payable to the Supreme Grand Chapter of India and the Regional Grand Chapter of Southern India respectively at the prevailing rates. Out of the annual subscription, a sum of Rs.200/- per companion shall be allocated to a Stewards' Fund and the same shall be utilized to defray, the dinner charges of the Companions and visitors at the regular Convocations excluding installation Convocation and Fellowship at all Convocations. Any Companion allowing his subscription to remain unpaid for more than six months shall be liable for exclusion under Rule 156 of Book of Constitution.</div>
