




Existing By-Laws	Amended By-Laws
<p>By-Law No. 8</p> <p>The Treasurer shall have charge of and be responsible for the moneys and account books of the Lodge. He shall enter the details for money received and paid out, in appropriate books of accounts. He shall collect the subscription and other dues, if any from members and deposit them in the name of the Lodge in a Bank approved by resolution of the Lodge. He shall have authority to pay as and when they fall due all routine expenses of the Lodge such as Grand Mark Lodge and Regional Grand Mark Lodge dues, contributory share, electricity charges. Summons printing charges, Warden's fees, and sundry expenses. All other payments shall be made only on the authority of the Lodge or the Worshipful Commander or the officer-in-charge of the Lodge. At the Installation Meeting he shall place before the Lodge the accounts written upto 30th November previous, audited and certified as correct by the Audit Committee.</p>	<p>By-Law No. 8</p> <p>The Treasurer shall have charge of and be responsible for the moneys and account books of the Lodge. He shall enter the details for moneys received and paid out, in appropriate books of accounts. He shall collect the subscription and other dues if any from members and deposit them in the name of the Lodge in a Bank approved by resolution of the Lodge. He shall have authority to pay as and when they fall due all routine expenses of the Lodge such as Grand Mark Lodge and Regional Grand Mark Lodge dues, contributory share electricity charges. Summon printing charges, Warden's fees and sundry expenses. All other payments shall be made only on the authority of the Lodge or the Worshipful Commander or the officer-in-charge of the Lodge. At the Installation Meeting he shall place before the Lodge the accounts written upto 31st October previous audited and certified as correct by the Audit Committee. All cheques must be signed Jointly by Treasurer along with either W.C.N or Scribe.</p>


