
**SUB:AMENDMENT TO BYE-LAWS OF

<p>By Law No.:13</p> <p>The Treasurer shall collect subscriptions and other dues and shall issue receipts there for. He shall be in charge of all moneys and market payments for current routine expenses with the permission of the Master. All moneys shall be deposited in a bank approved by the Lodge and in the name of the Lodge. The treasurer and master are authorized to operate on the accounts jointly. He shall submit financial statements to the Regular meeting of the lodge. The disbursement of any amount exceeding Rs. 50/- otherwise than for routine expenses requires the previous sanction of the Lodge, under notice. He shall maintain separate accounts for the General Funds and Charity Funds. He shall also at each meeting make a report of members in arrears for over three quarters</p>	<p>By Law No.: 13</p> <p>The Treasurer shall collect subscriptions and other dues and shall issue receipts there for. He shall be in charge of all moneys and make payments for current routine expenses with the permission of the Master. All moneys shall be deposited in a bank approved by the Lodge and in the name of the Lodge. The treasurer is authorized to operate on the accounts jointly with the Master or Secretary. He shall submit financial statements to the Regular meeting of the lodge. The disbursement of any amount exceeding Rs. 1000/- otherwise than for routine expenses requires the previous sanction of the Lodge, under notice. He shall maintain separate accounts for the General Funds and Charity Funds. He shall also at each meeting make a report of members in arrears for over three quarters</p>
<p>By Law No.: ----</p>	<p>By Law No : 15</p> <p>Concept of Mutuality: (to be inserted as Bye Law No. 15)</p> <p>All activities of the Lodge at all times be for the common benefit of all the members and for the public at large without any distinction as to Cast, Creed or Religion. No part shall be a business activity for the individual or collective benefit of any or all the members</p>
<p>By Law No : 15</p> <p>The stewards shall have charge of all Lodge furniture, and Regalia and shall see that they are kept in good order. They shall also see that the preparation for the meeting are adequate and with the Tyler see that no defects may occur to mar the proceedings. They will also be in charge of banquets and refreshments. All expenses connected with these shall be borne by the members partaking same including their guests if any. A sum not exceeding Rs.5/- shall be borne by the Lodge for aerated waters only at each meeting. If ant light refreshments are ordered, the Stewards will promptly collect the dues and disburse the expenses</p>	<p>By Law No : 16</p> <p>The stewards shall have charge of all Lodge furniture, and Regalia and shall see that they are kept in good order. They shall also see that the preparation for the meeting are adequate and with the Tyler see that no defects may occur to mar the proceedings. They will also be in charge of banquets and refreshments. All expenses connected with these shall be borne by the members partaking in the same including their guests if any. The Stewards will promptly collect the dues and disburse the expenses</p>


