By-Laws No 7(6) Initiation and Joining : (6) The scale of fees payable for initiation by a candidate : (i) Initiation Rs.1,500/- (ii) Joining from Grand Lodge of India Rs. 800/- (iii) Joining from other Constitutions Rs.1,000/- (iv) Rejoining Rs. 800/- In addition to the above, the candidates for Initiation / Joining / Rejoining shall also pay the prescribed initiation fees / joining fees to the Grand Lodge of India and the Regional Grand Lodge of Southern India at the prevailing rates.	By-Laws 7(6) Initiation and Joining : (6) The scale of fees payable for initiation by a candidate i. Initiation Rs. 3,000/- ii. Joining from Grand Lodge of India Rs. 1,000/- iii. Joining from other constitutions Rs. 1,500/- iv. Rejoining Rs. 1,500/- In addition to the above, the candidates for Initiation / Joining / Rejoining shall pay a sum of Rs.500/-. The prescribed initiation / joining / rejoining fee to the Grand Lodge of India and the Regional Grand Lodge of Southern India at the prevailing rates.



By-Laws 5 Subscription : Every Resident Member shall pay an annual subscription of Rs.1,000/- and every Non-Resident Member shall pay an annual subscription of Rs.750/-. In addition, both Resident and Non- Resident member shall also pay a sum of Rs.500/- annually towards the Steward Fund Account and the annual dues payable to the Grand Lodge of India and the Regional Grand Lodge of Southern India, as may be applicable from time to time






