EXPLANATORY

NOTE

The lodge is facing difficulties in operating its bank accounts in the absence of a PAN card. This is on account of the lodge not being able to show an adequate proof of address. The Lodge had many years ago already approved that the Secretariat of the lodge would be at Sreepatham Krishnaswamy Road, Cochin 682 035. It is felt by incorporating this clause in the bylaws it may facilitate the granting of a PAN Card for the lodge.
