





The W. Master shall appoint the Editor of the Journal and the Advisor at the First Regular Meeting of each year. The Secretary of the Lodge shall be the publisher and Sectretary of this Editorial Committee. The W. Master shall be the Chairman of the Editorial Committee.</p>
