<p>By-Law No. 6 (FEE &amp; SUBSCRIPTION)</p> <p>The following are the fees and Subscription of the Chapter strictly payable in advance</p> <p>Exaltation Rs. 500 Joining Rs. 250 Subscription Quarterly Resident Members Rs.125 Non Resident Members Rs.50 Out of the Quarterly Subscription of Resident Rs.125 paid by the resident member , a sum of Rs.75 shall however be credited to the Stewards fund to cover the dinner and Rs.50 towards the general fund. Resident absent members(RA) who are invalid, infirm, disabled or in financial distress and unable to attend the convocation of the Chapter shall on application be charged a monthly subscription of Rs.15.00 instead of the fee presented under no.6 of the Chapter. They shall however be charged the prescribed fee of resident members for the month/months in which they attend the convocation of the Chapter.</p>	<p>By-Law No. 6 (FEE &amp; SUBSCRIPTION)</p> <p>The following are the fees and Subscription of the Chapter strictly payable in advance</p> <p>Exaltation Fees: Rs. 1000/- Joining and Rejoining Fees: Rs. 500/- <b>Quarterly Subscription</b> Resident Members Rs.150/- Non Resident Members Rs.75/- Out of the Quarterly Subscription of Rs.150 paid by the resident members , a sum of Rs.70 shall be credited to the Stewards fund to cover the dinner and Rs.50 towards the general fund. 20% of any Subscription amount received shall be credited to the Charity Account. Resident absent members(RA) who are invalid, infirm, disabled or in financial distress and unable to attend the convocation of the Chapter shall on application be charged a quarterly subscription of Rs.50.00 instead of the fee prescribed under Bye law no.6 of the Chapter. They shall however be charged the prescribed fee of resident members for the month/months in which they attend the convocation of the Chapter. In addition to the subscription , the membership fees levied by the Supreme Grand Chapter of India and the Regional Grand Chapter of India shall are payable by all members in advance during the month of January of every year.</p>
