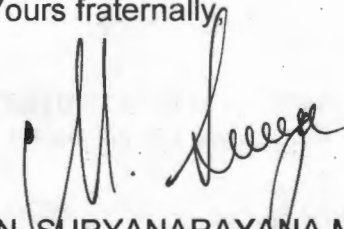

PLUS DUES TO THE GRAND LODGE AND THE REGIONAL GRAND LODGE AS AT PREVAILING RATES IN THE RESPECTIVE YEARS AND OTHER LEVIES PRESCRIBED BY THE GRAND LODGE, REGIONAL GRAND LODGE AND FROM THE LODGE FROM TIME TO TIME.	<u>By LAW NO - 10</u> <u>PROPOSED</u> THE SUBSCRIPTION SHALL BE PAYABLE AS FOLLOWS. RESIDENTS:- RS 750/- PER ANNUM. NON RESIDENTS:- RS 375/- PER ANNUM. PLUS DUES TO THE GRAND LODGE AND REGIONAL GRAND LODGE AS AT PREVAILING RATES IN THE RESPECTIVE YEARS AND OTHER LEVIES PRESCRIBED BY THE GRAND LODGE, REGIONAL GRAND LODGE FROM TIME TO TIME.
