**KNOW YE** that We by the authority and under the sanction of **Grand Lodge of Mark Master Masons of India** vested in us for that purpose and at the humble petition of Brethren Dr. Tirupur Thirumalaisamy Sellvaraj, Palaniswamy Jagannathan, Veerappan Varadharaj, Kuppanur Chinnasamy Manoharan, Dorairaj Subbieramaneam, Senthil Ramachandran, Krishnan Vivekkananda, Subramaniam Senthilkumar, Sivachalam Harishankar, Samanaidu Krishnan Kannappan, Dr. Subramaniam Krishnamurthy, Ramasamy Kannusamy, Arunachalam Selvaraj, Pollachi Nataraj Shanmugasundaram, Avinasiappan Karthikeyan, Balakrishnan Nambiar, Tirupur Shanmugasundaram Swaminathan, Lakshminarayan Rajesh, Rajavel Ramalingam, Venkatesan Kavasserri Balakrishnan, Palanisamy Duraisamy and Ramasamy Narayanan. who are regularly registered Mark Master Masons do hereby constitute the said Brethren into a regular **Mark Lodge** under the title of

**Mark Lodge Tirupur No. 185**

**On** the Register of the **Grand Lodge of Mark Master Masons of India** and appoint Brother **Dr. Tirupur Thirumalaisamy Sellvaraj** to be the **First Master**, Brother **Palaniswamy Jagannathan** to be the **First Senior Warden** and Brother **Veerappan Varadharaj** to be the **First Junior Warden** of the said Lodge giving to them and their successors regularly elected and installed authority to convene a Lodge of Mark Master Masons at **Masonic Temple, Sundamedu, Tirupur on the First Thursday of February, May, August and November.**

**IT IS HEREBY DECLARED** that these Brethren and their successors in office on behalf of themselves and the said Lodge by the acceptance of this **Warrant** become bound now and hereafter to preserve the landmarks of the Order, observe its **Antient** usages and established customs, and to obey and confirm to all regulations from time to time made by the **Grand Lodge of Mark Master Masons of the Government of the Mark Degree** and strictly to enforce them within their own Lodge upon these conditions only this **Charter or Warrant** is granted and it is revocable in default of strict compliance therewith.

**LASTLY** the Grand Master for himself and his successors declares that on the compliance with these conditions and Regulations of the **Grand Lodge of Mark Master Masons** which may from time to time be promulgated he will protect and uphold this Lodge and every **Mark Master Masons** Lawfully advanced therein.

**GIVEN** under our hand and seal of our **Grand Lodge of Mark Master Masons** at the Freemasons' Hall, New Delhi this 18<sup>th</sup> day of April, 2024, corresponding to 28<sup>th</sup> day of Chaitra, 1946, Saka Era.
