PREAMBLE

Whereas under the Constitutions the Grand Lodge of India, every daughter Lodge has the power of framing proper by-laws for its government, the same not being Contrary to or inconsistent with the land marks and constitutions of the order the following by-laws duly approved by the founder members and adopted at the consecration meeting of the Lodge and approved by the R W Regional Grand Master and by the Most Worship Grand Master; and such alterations additions or amendments as may be made from time to time in conformity with the rules and regulationse governing the same shall be binding on all members of the Lodge Meenakshi No 269 on the Register of the Grand Lodge of India, under the Jurisdiction of the Regional Grand Lodge of Southern India.

THE BY - LAWS OF LODGE MEENAKSHI No. 269

Without due order and decorum, harmony cannot be preserved, nor the business of masonry properly conducted; therefore, at the stroke of Master's Gavel profound silence shall be observed.

I. MEMBERS

1. The members of the Lodge shall comprise of two classes, viz.
 - a) Honorary
 - b Regular
2. a) Honorary Members shall be those who are elected as such for services rendered to Masonry in general or to this Lodge in accordance with the provisions of Rule 142 Book of Constitutions.
- b) Regular Members shall be those who join as subscribing members.

II. MEETING

3. The regular meeting of the Lodge shall be held at the Freemasons' Hall on the fourth Saturday of all months in the year except during the month of May, at such convenient hour as shall be entered in the Summons and every Brother attending shall sign his name in the attendance book kept for that purpose.

4. The expenses of an emergency meeting shall be defrayed by the Brother or Brethren on whose account the Lodge is summoned in addition to the dispensation fees, if any. But when an emergency meeting is called for the Lodge purposes, all expenses shall be defrayed from Lodge Funds.

III. PROCEDURE AT MEETING

5. Any number of amendments duly proposed and seconded may be made to any proposition, in which case, the amendments shall be put first and if they are negatived, the original proposition shall be put to the vote. If any amendment is carried, the proposition as amended shall be put to the vote.

IV. DUES AND FEES

6. The fees and subscription payable to the Lodge shall be as follows:

a) Annual Subscription	... Rs. 245-00
b) Initiation Fee	... Rs. 300-00
c) Joining Fee from Indian Constitution	... Rs. 50-00
d) Joining Fee from other Constitutions inclusive of the cost of Grand Lodge Certificate	... Rs. 100-00
e) Re-Joining Fee	... Rs. 50-00

- f) Installation Fee of Honour, devoted to Lodge Charity Fund ... Rs. 50-00
- g) Fee for an emergency meeting ... Rs. 50-00

Note : a) A member initiated or joining in any month of a year shall pay his subscription for the entire year. The official year of the Lodge shall be the English calendar year for purpose of the collection of the subscription for membership.

b. All Members of the Lodge shall be members of Madurai Masonic Trust and shall pay the entrance fee along with the Initiation or Joining Fee and also the annual subscription both of which shall be considered as dues.

c) At the time of admission a sum of Rs.5/- towards entrance fee for Masonic Trust and also Rs. 10/- annual subscription for the same may be collected.

7. All subscription shall be payable in full in advance and all fees shall also be payable in advance.

8. All sums payable by member under By-Law Nos. 31 and 32 and charged to their respective accounts shall be considered as "Dues" and are payable within the next month.

V. ADMISSION OF MEMBERS AND MEMBERSHIP

9. No candidate for initiation or Joining or Re-Joining shall be ballotted for unless the prescribed fees shall have been previously paid and the prescribed forms duly filled in by the candidate with all other consequential documents, if any, have all been previously deposited with the Secretary.
10. No candidate for Initiation or Joining shall be admitted, if on the ballot, two black balls appear against him. No rejected candidate shall be again proposed until twelve months have elapsed.
11. If a candidate for Initiation is not initiated within one year (as defined by R. 135 of B of C.) after the date of the ballot at which he was elected, his election shall be void.
12. In the event of rejection of the candidate for Initiation or Joining, or deferred initiation, for over twelve English calendar months, the admission fees previously paid shall be returned.
13. A member desirous of terminating his membership of the Lodge shall tender his resignation in writing or orally in open Lodge, and he shall be entitled to the certificate mentioned in Rule 150 (a) and (b) Book of Constitutions stating the circumstances in which he left the Lodge.

14. No Brother who has resigned or has been excluded for non-payment of dues, shall be permitted to rejoin unless he shall have paid up all dues and unless he is again regularly proposed and seconded and ballotted for in the usual course.
15. Except with the special permission of the Master or unless recommended by the Lodge Committee no proposal shall be brought forward for consideration by the Lodge unless it is proposed and seconded in open Lodge at the regular meeting or is given in writing to the Secretary duly proposed and seconded fifteen days prior to the next regular meeting. With the exceptions noted above, no proposal shall be considered in the Lodge unless it has been notified in the Summons for the Meeting concerned.

VI ARREARS OF DUES

16. When the subscription of a member is unpaid for a year, he will be ineligible to vote or propose or be appointed or elected to office, and shall be liable to exclusion on a vote of the Lodge in accordance with Rule 156 of the Book of Constitutions.

VII. NOTICE AND SUMMONSES

17. a) Notices and Summonses which it shall be requisite to send to any member, shall be deemed sufficiently served, if sent through ordinary post to the last known address

of a member. Every notice of exclusion or intended exclusion shall be sent through registered post for acknowledgement due.

- b) All changes of addresses shall be invariably notified to the Secretary in writing by members, directly they occur.

Note : The Secretary and Treasurer shall always be addressed as such, in virtue of their office and never by name, as it frequently happens that letters addressed to the Lodge Officers by name are forwarded as private letters, if such officers have left the station.

VIII. ELECTION OF MASTER, TREASURER AND TYLER

18. The Master and Treasurer shall be elected by ballot and the Tyler elected by show of hands at the Regular Meeting in October of every year. The Master-elect shall be installed at the next Regular Meeting in November.

IX. LODGE COMMITTEE

19. A Lodge Committee consisting of the Master, Wardens, Past Masters, Treasurer, and Secretary of the Lodge for the time being and two members elected by the Lodge at the Regular Meeting in November shall conduct all business of the Lodge, superintend the finances and the property of the Lodge and consider any subject relating to its interest. It shall meet atleast once a month when summoned by the Master (three to

form a quorum) and the result of its proceedings shall be reported at the regular meeting of the Lodge.

X. ANNUAL AUDIT COMMITTEE

20. At the regular Meeting in October of every year, the Lodge shall appoint the Audit Committee, consisting of three members. The Secretary and the Treasurer shall attend the meetings of the Audit Committee.
21. The duties of the Audit Committee shall be :
- i) To inspect and to take an inventory of the property of the Lodge, mentioning its state and condition.
 - ii) To examine the Secretary's books and audit the Treasurer's accounts.
 - iii) To draw up a report of the result of their examinations and of the working of the Lodge during the past year; in this respect they may suggest any matter tending to promote the welfare of this Lodge.
22. The report of the Annual Audit Committee shall be submitted to the Lodge at the Regular Meeting in November of each year, before the installation of the Master, which after being read, shall be entered in the Minutes Book and printed and distributed for the information of the Brethren.
23. Any suggestion made in the Annual Report must be put to the Lodge in the shape of

a proposition duly seconded, approved by the Brethren and confirmed before being carried into effect.

XI. SPECIAL COMMITTEES

- 24 a) There shall be constituted a Committee on Admissions of new candidates, consisting of the Master and two Brethren, elected in Open Lodge, at the Installation Meeting in November each year. It shall be the duty of this Committee to consider and report to the Lodge on all proposals for membership.
- b) The Lodge may, at its discretion, nominate other Committees for the conduct and consideration of special subjects consisting of not less than three members, a Past Master being included, if possible, three to form a quorum. The results of its proceedings shall be reported at a regular Meeting of the Lodge and any suggestions made must be put to the Lodge in the shape of a proposition as in By-Law No 24

XII WARRANT, PREMISES, FURNITURE, ETC OF THIS LODGE.

25. a) The Warrant of this Lodge together with the Jewels, Regalia, Archives and all properties of the Lodge (a List of which shall be kept by the Secretary) shall vest in and be under the absolute control of the Master and Wardens for the time being in trust for the members of the Lodge,

but shall not be sold or otherwise disposed off, except by resolution of the Brethren in open Lodge, assembled, regularly proposed, carried and confirmed. No property of the Lodge shall be lent or hired except for purely Masonic purposes.

XIII. DUTIES OF OFFICERS

TREASURER

26. a) All moneys due to or held for, the Lodge shall be paid or remitted to the Treasurer direct, who shall without undue delay, deposit the same in an account or accounts opened in the name of the Lodge at a Bank or Banks to be approved by resolution of the Lodge. The Lodge Funds so deposited with the Bank or Banks will be subject to withdrawals against the joint signatures of Master and the Treasurer.
- b) Except for routine expenses, no sum of money shall be expended by the Treasurer without the sanction of the Lodge.
- c) He shall keep a cash account of all receipts and disbursements and a Ledger account for each member which later shall be open for inspection of the member to whom it relates on application to the Treasurer

- d) He (Treasurer) shall maintain separate accounts for the General Funds, Charity Funds, and each and every other Special Fund, that may be in existence or may be set up from time to time and also as far as possible deposit them in separate accounts with Bank or Banks, as may be approved by the Lodge.
- e) The accounts shall be made up by him and audited by the Committee appointed under By-Law No. 20. He shall also prepare the annual balance sheet and present it to the Audit Committee (for this purpose 1st November to 31st October shall be taken to be the official year of the Lodge).
- f) To enable By-Law No. 16 to be enforced, the Treasurer shall report at each meeting the names of members who are in arrears for a year.
- g) The Treasurer shall, at the beginning of the month of November, each year, transfer from the General Fund of the Lodge :
 - i) Rs. 15/- per member per year to the Charity Fund of the Lodge.
 - ii) Rs. 40/- per member per year to the Stewards Fund of the Lodge.

SECRETARY

- 27. a) The Secretary shall issue summons to all the members of the Lodge atleast seven days prior to each regular Meeting setting forth all the business to be entered upon; the amount of dues, if any, from each Brother shall be entered on his summons.
- b) He shall also keep proper Minutes of the proceedings of the Lodge.
- c) He shall keep the Register which shall give full particulars concerning the members of the Lodge as required by the Rule 120 of the Book of Constitutions. He shall prepare for the signature of the Master all the necessary and regular Returns required by the Grand Lodge of India and by the Regional Grand Lodge of Southern India.
- d) All letters from the members of the Lodge shall be addressed to him.
- e) He shall keep a list of all Lodge properties.
- f) He shall be Ex-officio member and Secretary of all Committees and Special Committees appointed by the Lodge sending out the notices.

XV. STEWARDS

28. a) The Stewards, if appointed, shall have charge of all furniture and Regalia and shall see that the Tyler keeps them in good order and provides everything requisite in the Lodge. They shall see that the Lodge is always properly prepared for meetings and shall make the necessary arrangements about the refreshments, banquets, etc.

b) The Chairman of the Stewards' Committee or in his absence the Senior Steward available or in his absence any member appointed by the Master for that purpose shall arrange for subscribed lunches, dinner and / or light refreshments. He will draw necessary funds from the Treasurer out of the Stewards' Fund and meet the cost of food and light refreshments for the regular members.

c) The Chairman of the Stewards' Committee or the member in-charge shall forthwith submit an account expended by him from out of the Stewards Fund.

THE TYLER

29. The Tyler shall take care of and keep in good order the Lodge furniture, Regalia, etc. He shall prepare the Lodge before

meetings and shall see that every person whether member or visitor enters his name in the Attendance Book previous to his admission to the Lodge.

30. The Tyler, if he happens to be a serving brother, shall be paid a fee of Rs. 10/- for each meeting attended and his dinner charges also shall be paid from out of the general fund of the Lodge.

XIV. BANQUETS, REFRESHMENTS, ETC.

31 a) All expenses connected with subscribed dinners banquets, lunches and light refreshments with respect to regular members after the regular meeting of the Lodge, shall be borne from out of the Stewards' Fund of the Lodge. Charges for visiting Masons shall be paid by them or by the members inviting them. For Lodge guests, payment shall be made under such arrangements as may be made from time to time by the Lodge.

b) The above arrangement with respect to regular members, shall not include Festive Boards in connection with emergency meetings, special meetings, Ladies' Nights and such other meetings and get-together or gatherings for which charges will be payable extra.

XV. ALMS (CHARITY FUND)

32. Before closing at each meeting, Regular or Emergency, the Master may direct the charity box to be circulated in order that all the Brethren present may deposit free will offerings.
33. The sum thus collected shall be kept separate from the Lodge funds and appropriated to such charitable purposes as the Brethren in the open Lodge may direct.

XVI. MISCELLANEOUS

34. Members introducing visitors, shall see that the visiting Brethren introduced by them sign the Attendance Book.

XVII. BY-LAWS

35. Every member of the Lodge, Initiated in or Joining the Lodge, shall be presented with a printed copy of the By-Laws, free of charge. The By-Laws shall be read in the open Lodge once every year and at such other time as the Master may think it proper.
36. No alteration, or addition or amendment shall be made to those By-Laws unless moved and seconded in Open Lodge, due notice of such action having been sent in the Summonses

to each member, nor shall each alteration or amendment be considered carried unless two-thirds of the members present vote in its favour. The alteration, addition or amendment shall come into force only after it is duly approved by the R. W. the Regional Grand Master, Regional Grand Lodge of Southern India and M. W. The Grand Master.

A CONCORDAT

Between

Lodge Pandyan No. 49, Lodge Rajasabai No. 212

and

Lodge Meenakshi No. 269

WHEREAS Lodge Pandyan has spontaneously sponsored the founding of the additional Craft Lodges Rajasabai and Lodge Meenakshi, in Madurai, for the betterment of Masonry in general and for the strengthening of the Masonic fraternity in and around the city of Madurai, in particular :

WHEREAS it is desired and considered by the three Lodges, that amity, co-operation, brotherly love and relationship between the three Lodges should be maintained, upheld and continued in perpetuity :

WHEREAS the three lodges want to have a Concordat :

THIS Concordat between the three Lodges sheweth :

1. That Lodge Pandyan voluntarily agrees that Lodge Rajasabai and Lodge Meenakshi can make use of the Masonic premises, Temple, Library, Guest Room, extensions, ground and appurtenances and fittings belonging to Lodge Pandyan, for all their regular, emergent and all other meetings, Committee meetings, Masonic get-togethers, Ladies' Nights and all other Masonic Functions, without any objection or restraint or restriction, from Lodge Pandyan :

2. That Lodge Rajasabai and Lodge Meenakshi are entitled to have and enjoy the services of the clerks, attenders, assistants, peons and all other employees of Lodge Pandyan as well as all office equipments such as type-writer etc. without any restriction, conditions etc
3. That Lodge Rajasabai and Lodge Meenakshi may make use of all the conveniences, including electric lights, fans, refrigerators, protected water supply and all other amenities that are now available and may hereafter be provided from time to time
4. That Lodge Rajasabai and Lodge Meenakshi shall have a right to equip, store and use within the Lodge building and premises, their own furniture, regalias, cupboards, equipments, records, files, registers, photographs paintings, name boards etc., without disturbing the existing arrangements and obtaining prior permission of Lodge Pandyan as to the proper size and positioning of the enlargement, photographs, plaques, boards etc. The premises committee of Lodge Pandyan is at liberty to relocate any or all of them at any time and to specify the dimension of such enlargements, photographs, plaques etc.
5. That each Lodge shall provide itself with its own regalias, (Aprons, Collars, Jewels, Gauntlets etc) and Cupboards for their safe storage and for the exclusive use of its own members.
6. That Lodge Rajasabai and Lodge Meenakshi unequivocally declare that they shall have no

property right whatsoever or any ownership claim on any of the buildings, premises, furnitures, fittings, equipments, etc, except that they shall have the right to enjoy and use them as detailed above :

7. That Lodge Rajasabai and Lodge Meenakshi hereby undertake to pay Lodge Pandyan a per capita on each and every subscribing member-honorary and serving members exempted. A per capita of Rs. 85/- (Rupees eighty five only) per member per year is payable for the time being, that this per capita is subject to change from time to time by mutual consideration and consent between Lodge Pandyan, Lodge Rajasabai and Lodge Meenakshi and that it is hereby mutually agreed that this sum shall be adequate consideration for the time being for making use of and enjoying all the Buildings, Temple, extensions, Library Rooms, grounds, equipments, fittings etc, as envisaged in clauses 1, 2 and 3 above: and that no other additional payment or payments will be demanded by Lodge Pandyan from Lodge Rajasabai and Lodge Meenakshi.
8. That Lodge Rajasabai shall pay per capita on all its subscribing members as may be on roll on the 1st July of each year, paying the entire per capita so calculated on or before the 31st August of same year and Lodge Meenakshi shall pay per capita on all its subscribing members as may be on roll on the 1st October of each year, paying the

entire per capita so calculated on or before the 30th November of the same year.

9. That Lodge Rajasabai and Meenakshi hereby agree to pay the cost of repairs or replacements for breakages or damages to any property of the Lodge Pandyan, that may be caused while being used by the two but not for the damages or breakages that may occur due to normal wear and tear.
10. That all the Lodges hereby mutually agree and declare that all fees and dues of the Lodges as charged on the members as per their by-laws, should always be identical and that there should be no variation or differences and that when any one of the three Lodges contemplate making any change in tariff or dues, it shall notify the other Lodges of its intention, and such revisions will be considered by the other two Lodges and after mutual consultation the revised fees and charges be implemented as effective simultaneously from a date as may be agreed upon
11. That to have a healthy co-ordination and to avoid unpleasant rivalry the three Lodges agree that prior to proposal of a candidate either for initiation, or joining, any one of the Lodges, it shall be necessary for the Lodge in which the proposal has to be made to inform the other two Lodges of the said proposal so that it may ascertain whether the candidate's name had at all been proposed

in that Lodge before, and whether it had been rejected or postponed due to unfavourable report or objection; and in all such cases, the other two Lodges, shall not on any account entertain the proposal of that candidate

12. That the three Lodges feel and agree that wherever the three Lodges shall jointly endeavour to conduct and celebrate such Masonic functions like anniversaries, Ladies' Nights, Past Masters' Nights, receptions welcome to Masonic dignatories when they visit Madurai on any Masonic event;
13. That it is mutually agreed that the Regional Grand Lodge Meetings, Grand Lodge Meetings or other Masonic events could be hosted jointly by all three Lodges wherever possible; and that whenever necessary joint meetings of Lodges could be held on proper occasions to further cultivate and encourage amity and fraternal bond between the Lodges.
14. That the three Lodges hereby solemnly affirm that none of the three Lodges shall do any thing which will affect the harmony and peaceful working of the other Lodges, and it shall be the constant endeavour of all the three Lodges to promote fellowship, fraternal love and affection between the brethren of the Lodges
15. In case any alteration, revision, amendment or cancellation to the above clauses are deemed

required to be made by any of the three Lodges, such alterations, revision, amendment or cancellation may be advised to the other Lodges in advance and with their mutual consent, the matter be brought as a notice of motion by all three Lodges at one of their meetings and voted upon at the next meeting of the three Lodges.

16. All the three Lodges agree to have this Concordat incorporated in the Book of By-laws of the respective Lodges, with the necessary inclusion of revisions etc. marked from time to time.

Unanimously adopted by Lodge Meenakshi at its regular meeting on 28-2-87.

SEND GREETINGS

Know Ye That We by the authority and under
sanction of the Grand Lodge of India vested in us for
that purpose and at the humble petition of our Right
Trusty and Well Beloved Brethren A.S. Rajasabai,
V. Nagoor Pitchai, P. Shanker, V. Rajendran,
P.V. Parthasarathy, N.M.R.V. Sivapressadh, S. Rengarajan,
SP. Annamalai, R. Gurumurthy, N.M.R.S. Poornachandran,
S. Jeyaprakash, S.S. Babulal,

and others do hereby constitute the said Brethren
into a Lodge of Free and Accepted Masons under the
title or Denomination of

The Meenakshi Lodge No. 269

The said Lodge to meet at Freemasons' Hall, Race
Course Road, Madurai, on the Fourth Saturday of Every
Month, empowering them in the said Lodge when duly
congregated to make, pass and raise Freemasons accord-
ing to the Ancient Custom of the Craft in all Ages and
Nations throughout the known World And further at
their said Petition and of the great trust and confidence
reposed in every of the abovenamed Brethren WE DO
APPOINT the said *Ayya Shenbaga Rajasabai* to be the
first Master, the said *V. Nagoor Pitchai*, to be the
first Senior Warden and the said *P. Shanker* to be the
first Junior Warden for opening and holding the said
Lodge and until such time as another Master shall be
regularly elected and installed, strictly charging that every
member who shall be elected to preside over the said
Lodge and who must previously have duly served as
Warden in a Warranted Lodge shall be installed in
Ancient Form and according to the Laws of the Grand
Lodge that he may thereby be fully invested with the
dignities and powers of his Office. And we do require you
the said *Ayya Shenbaga Rajasabai* to take special care
that all and every the said Brethren are or have been
regularly made Masons and that you and they and all
other the Members of the said Lodge do observe, perform
and keep the Laws, Rules and Orders contained in the
Book of Constitutions and all others which may from time
to time be made by our Grand Lodge or transmitted by us
or our Successors Grand Masters or by our Deputy Grand
Master for the time being and we do enjoin you to make
such By Laws for the government of your Lodge as shall
to the majority of the Members appear proper and necess-

ary, the same not being contrary to or inconsistent with the General Laws and Regulations of the Craft, a Copy whereof you are to transmit to us. And we do require you to cause all such By Laws and Regulations and also an Account of the proceedings in your Lodge to be entered in a Book to be kept for that purpose. And you are in no wise to omit to send to us or our Successors Grand Masters or to Our Deputy Grand Master for the time being at least once in every year a list of the members of your Lodge and the names and descriptions of all Masons initiated therein and Brethren who shall have joined the same with the fess and monies payable thereon. It being our will and intention that this Our WARRANT OF CONSTITUTION shall continue in force so long only as you shall conform to the Laws and Regulations of our Grand Lodge And you the said *Ayya Shenbaga Rajasabai*, are further required as soon as conveniently may be to send us an Account in writing of what shall be done by virtue of these Presents.
