ITEM 3

(i)(a) EVERY MEMBER SHALL PAY RUPEES (RS 40/-) PER MONTH IN ADVANCE AS SUBSCRIPTION TO THE TREASURER ON OR BEFORE THE DAY OF THE REGULAR MEETING. A BROTHER WHO HAS NOT PAID HIS SUBSCRIPTION BEFORE THE REGULAR MEETING SHALL BE CONSIDERED TO BE IN ARREARS FOR THAT MONTH. THE MONEY MAY BE PAID IN CASH OR CROSSED D.D. OR BY CROSSED CHEQUE IN FAVOUR OF "LODGE MANGALORE".

b) APART FROM THE LODGE DUES AS ABOVE AS IN 3(1)a. THE MEMBER ALSO HAS TO PAY THE OTHER DUES AS APPLICABLE AS MENTIONED BELOW:
