IV. DUES AND FEES

6. The fees and subscriptions payable to the Lodge shall be as follows:

- (a) Subscriptions for each year
 - i) Of Resident Member - Rs 750
 - ii) Of Out-station Member - Rs 700
 - iii) Of Non-resident Member - Rs 400
 - iv) Life Member (one time subscription) - Rs 5000
- (b) Initiation Fee - Rs 2500
- (c) Joining Fee from Indian Constitution:
 - i) Brethren of Lodge Pandyan and Lodge Meenakshi - Rs 1000
 - ii) From other Lodges - Rs 1500
- (d) Joining Fee from Other Constitutions - Rs 2000
- (e) Re-joining Fee - Rs 1500
- (f) Installation Fee of Honour, payable by and devoted to Charity Fund of the Lodge
 - WM - Rs 250
 - SW - Rs 100
 - JW - Rs 100
- (g) Fee for an Emergency Meeting: - Rs 150
- (h) Entrance Fee for Madurai Masonic Trust - Rs 50
- (i) Annual Subscription for Madurai Masonic Trust - Rs 50
- (j) as may be decided from time to time

- (c) Joining Fee from Indian Constitution:
 - i) Brethren of Lodge Pandyan and Lodge Meenakshi - Rs 1500
 - ii) From other Lodges - Rs 2000
- (d) Joining Fee from Other Constitutions - Rs 2500
- (e) Re-joining Fee - Rs 2000
- (f) Installation Fee of Honour, payable by and devoted to Charity Fund of the Lodge
 - WM - Rs 1000
 - SW - Rs 500
 - JW - Rs 500
- (g) Fee for an Emergency Meeting: - Rs 150
- (h) Entrance Fee for Madurai Masonic Trust - Rs 50
- (i) Annual Subscription for Madurai Masonic Trust - Rs 50
- (j) Dues payable to GLI and RGLSI, as applicable from time to time
- (k) Madurai Pandyan Masonic Charitable Hospital - Rs 2000

NOTE: All Members of the Lodge shall be members of the Madurai Masonic Trust and shall pay Entrance Fee (along with Initiation or Joining Fee) and also the annual subscription, both of which shall be considered as dues.
