2 (a) CONVOCATIONS

The Regular Convocations of the Chapter shall be held at the Freemasons Hall, #2, Primrose Road Bangalore 560 025 on the Second Thursday of March, July, and November every year at such hour as may be directed by the Principals for each Convocation.

Regular Convocations of the Chapter shall be held at the Freemasons Hall, #2, Primrose Road Bangalore 560 025 on the Second Thursday of January, March, May, July, September, and November every year at such hour as may be directed by the Principals for each Convocation.

3. ELECTION AND INSTALLATION CONVOCATIONS

The Principals shall be elected annually at the Regular Convocation of the Chapter in July and shall be installed at the next Regular Convocation in November. The Treasurer and Janitor shall be elected respectively each year at the Regular Convocation of the Chapter in July and invested as such at the Installation Convocation in November

The Principals shall be elected annually at the Regular Election Convocation of the Chapter in September and shall be installed at the next Regular Installation Convocation in November. The Treasurer and Janitor shall be elected respectively each year at the Regular Election Convocation of the Chapter in September and invested as such at the Installation Convocation in November


6(b) FEES AND SUBSCRIPTIONS


Membership subscription will be as follows:
i. Rs.250/- payable to the Chapter per year

iii. Such annual dues payable to the Regional Grand Chapter of Southern India as may be fixed from time to time.


Membership subscription will be as follows:

PERMANENT
AND AUDIT
COMMITTEES**

There shall be a Permanent Committee composed of the three Principals, Immediate Past First Principal, Past Principals in and of the Chapter, the two Scribes, Treasurer, Director of Ceremonies and two Companions elected at the Installation Convocation. The Permanent Committee shall meet on 2nd Thursday of January, May and September or on such days and at such time as may be fixed by the Principals. The duties of the Permanent Committee shall be to consider the applications of Candidates/ Royal Arch Masons for Exaltation and Joining or Re-joining, check the accounts of the Chapter, make arrangement for the Convocations and Ceremonies thereof, consider all matters leading to the improvement of the Chapter..

There shall also be an Audit Committee of two brethren, whom are not members of the standing committee. The Audit Committee shall verify and audit the Annual Statement of Accounts of the Chapter and shall certify the correctness thereof before being circulated to all the members prior to the Installation Convocation.

There shall be a *Permanent Committee* composed of the three Principals, Immediate Past First Principal, Past Principals in and of the Chapter, the two Scribes, Treasurer, Director of Ceremonies and two Companions elected at the Installation Convocation. The Permanent Committee will meet on the 2nd Thursday of January, March, May, July, September, and November or on such days and at such time as may be fixed by the Principals. The duties of the Permanent Committee shall be to consider the applications of Candidates / Royal Arch Masons for Exaltation and Joining or Re-joining, check the accounts and the properties of the Chapter and report on the matters leading to the improvement of the Chapter.

There shall also be an *Audit Committee* composed of two Companions elected at the Regular Election Convocation in September along with the Principals, Treasurer and Scribe 'E' of the Chapter. The Audit Committee shall verify and audit the Annual Statement of Accounts of the Chapter and shall certify the correctness thereof before being circulated to all the members prior to the Installation Convocation.

The above *amendments* were regularly Proposed and Seconded in open Chapter at a Regular Convocation held on 12th July 2001. Passed at a Regular Meeting held on 14th March 2002 and confirmed at a Regular Meeting held on 11th July 2002.
