
(A) By-Law No. 5 Exaltation and Joining Fees	
<b>EXISTING</b> The fees to be paid for exaltation including Grand Chapter Registry and Certificate and also for joining shall be as follows : Exaltation Fees - Rs. 200/- Joining Fees - Rs. 100/- In case of Companions joining from a recognised sister Constitution, an additional payment of Rs. 10/- will be required.	<b>PROPOSED</b> The fees to be paid for exaltation including Grand Chapter Registry and Certificate and also for joining shall be as follows : Exaltation Fees - Rs. 300/- Joining Fees - Rs. 200/- Joining Fees from Other Constitutions - Rs. 300/- Rejoining Fees - Rs. 200/-
<b>(B) By-Law No. 6 - Membership and Subscription</b> Every Companion should pay a Subscription of Rs. 150/- and Steward Fund of Rs. 150/- totally Rs. 300/- per year.	Every Companion should pay a Subscription of Rs. 200/- and Steward Fund of Rs. 150/- totally Rs. 350/- per year along with the actual SGC and RGC of S.I. Annual Dues payable from time to time
Reason : Due to increase in administrative costs of printing, stationery, postage, etc., and SGC of I and RGC of S.I. Annual Dues.


