THE FEES TO BE PAID FOR EXALTATION INCLUDING GRAND CHAPTER CERTIFICATE AND ALSO FOR JOINING SHALL BE AS FOLLOWS.

- JOINING FROM THE SUPREME GRAND CHAPTER : Rs 300.

6) MEMBERSHIP AND SUBSCRIPTION.
