

# BYE-LAWS

OF

## LODGE JAYACHAMARAJA

Of Royal Ark Mariners

No. 53 Mysore

### MEMBERS

1. The Lodge shall consist of Resident and Non-Resident Members.

(a) Resident Members are those who are residing within a radius of 25 Kms. from the limits of Mysore City Corporation.

(b) Non-Resident Members are those who are not residing within the area stated above.

### DAYS OF MEETING

2. The Regular Meeting shall be held on the Second Sunday in the months of March, June, September and December at Freemasons' Hall, Mysore.

## ELECTION

3. The Annual Election of the W.C.N., Treasurer and Warder shall be held on the day of the Regular Meeting in the month of June-

## INSTALLATION

4. The W.C.N. elect shall be installed at the next Regular Meeting held in the month of September.

## TREASURER

5. All payments exceeding Rs 20-00 shall ordinarily be paid by cheque only. The Lodge money shall be deposited in such Bank as the Lodge may from time to time direct. The W.C.N. and Treasurer shall jointly operate the account or as may be resolved at the Installation meeting.

## SCRIBE

6. The Scribe shall keep such books and make such entries as are prescribed under Rule 10 R.A.M. of the Book of Constitutions and shall also collect all dues and fees and transmit all monies to the Treasurer.

## WARDER

7. The warder shall be paid a fee of Rs. 10.00 for his attendance at each meeting held and for Superinten-

ding the preparation of the Lodge Rooms. It shall be the Warder's duty to keep the Attendance Book and to see that all the Brethren who enter the Lodge sign their names in it, to examine carefully all visitors and to see that the Brethren are properly clothed and that the candidates are properly prepared.

## PERMANENT COMMITTEE

8. The Permanent Committee shall consist of W.C.N. and other Past Commanders of the Lodge, Wardens, Treasurer and Scribe. W.C.N. shall preside at such meetings and in his absence the I.P.C.N. and in the absence of any of these, the Warden Senior in rank.

The P.C. shall meet half an hour before the opening time of the regular meetings or as directed by W.C.N.

## FEES FOR ELEVATION AND JOINING

9. The fees to be paid for elevation including Grand Mark Lodge (RAM) Registry and certificate and also for joining shall be as follows.

Elevation fee                      Rs.    100/-

Joining fee                              Rs.    50/-

Fees for emergency meeting Rs. 30 + actual expenditure.

## SUBSCRIPTIONS

10. The Quarterly Subscription shall be as follows:

Resident Member Rs. 15-00 or Rs. 60-00 per annum. Rs. 5-00 out of this to be credited to a Stewards account to be operated by W.C.N. & J.W.

Non Resident Member Rs. 10-00 Annual subscription Rs. 40-00.

The scribe shall not be liable to pay any subscription.

## ARREARS

11. Any member whose dues will remain unpaid for a period of six months shall receive notice of the same from the Scribe and should they not be paid up within one month from the date of such notice, the Member shall be liable to be dealt with under Rule 109 and 110 of the book of Constitution of Grand Mark Lodge for exclusion and cessation.

## RESIGNATION

12. Any brother wishing to resign shall intimate the same either by letter to the Scribe or in open Lodge.

## EMERGENT MEETING

13. Should a Lodge of Emergency be summoned for the express purpose of elevating any Brother or Brothers, such a Brother shall pay an additional fee of Rs. 30-00 and meet the actual expenditure.

## ALTERATION OF BY-LAWS

It shall not be competent for the Brethren to abrogate, amend or alter these Bye-laws unless the abrogation amendment or alteration shall have been duly proposed and passed at one Regular Meeting, after insertion in the summons and read and confirmed at the next Regular Meeting of the Lodge. The change shall not become effective until subsequently approved by the R.G.M., and the Grand Master's Royal Ark Council.
