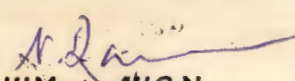

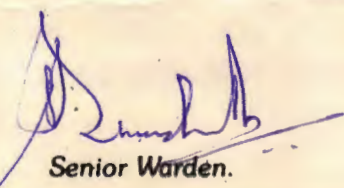
Existing By-Laws	Amended By-Laws										
By-Law No. members shall pay a subscription of ₹.25/- per quarter payable on the first day of the month of February, May, August and November. By-Law No. 7 members in arrears of subscription for over two quarters shall not be entitled to be appointed to any office in the Lodge and members in arrears of subscription of over one year may also be excluded in the manner provided under Rule 118 of the Book of Constitution(Mark) By-Law No. 8 The scale of fees for advancement and joining shall be as follows: <table> <tr> <td>Advancement fee</td><td>= 30.00</td></tr> <tr> <td>Joining fee for a member of the B.C.</td><td>= 10.00</td></tr> <tr> <td>Joining fee for a member of a recognised constitution</td><td>= 16.00</td></tr> </table>	Advancement fee	= 30.00	Joining fee for a member of the B.C.	= 10.00	Joining fee for a member of a recognised constitution	= 16.00	By-Law No. Each member shall pay Annual subscription of ₹.150/- and the dues payable per member to Grand Mark Lodge of India and Regional Grand Mark Lodge of Southern India as may be fixed by them from time to time before the end of the Calendar year. By-Law No. 7 members in arrears of subscription and dues payable to Grand Mark Lodge of India and Regional Grand Mark Lodge of Southern India for over 6 months from the due date as prescribed under By-Law No. 6 shall not be entitled to be appointed to any office in the Lodge and members in arrears of subscription of over one calendar year may also be excluded in the manner provided under Rule 118 of the Book of Constitution of Mark Lodge.
