Bye-law No. 4 SUBSCRIPTION: Every Resident Member shall pay Annual Subscription of Rs. 500 - 00 and Non-resident member shall pay Annual Subscription of Rs. 250 - 00 to the Lodge. In addition both Resident and Non-resident shall also pay Annual dues to the Grand Lodge of India and Quarterages to the Regional Grand Lodge of Southern India as applicable from time to time.	Bye-law No. 4 SUBSCRIPTION: Every Resident Member shall pay Annual Subscription of Rs. 500 - 00 and Steward fund of Rs. 100 - 00 and every Non-resident member shall pay Annual Subscription of Rs. 250 - 00 and Steward fund of Rs. 100 - 00 to the Lodge. In addition both Resident and Non-resident shall also pay Annual dues to the Grand Lodge of India and Quarterages to the Regional Grand Lodge of Southern India as applicable from time to time.
Bye-law No. 10 a) The Master Treasurer shall be annually elected at the Regular Meeting in November and shall be installed and invested at the next Regular Meeting in December. b) The Tyler shall also be elected at the Election Meeting in November. c) NIL	Bye-law No. 10 a) The Master and the Treasurer shall be annually elected every year at the Regular Meeting in November and shall be installed and invested at the next Regular Meeting in December. b) The Tyler shall also be elected at the Regular Meeting in November. c) Every year the accounts of the Lodge will be closed on 15th of November.
