9. a) Fees shall be paid in advance for all the three Degrees Rs 3,000-00 b) Joining from any Lodge under any Constitution Rs 3,000-00 c) Subscription from Resident members (per month) Payable in advance Rs. 250-00 d) Subscription from Non-Resident Members, and Resident Members in Absent list per month. Rs. 120-00 e) In addition to the above, Resident Members, Non-Resident Members and Resident Members in Absent List will pay Grand Lodge and Regional Grand Lodge dues, as specified from time to time, in advance, in lumpsum.	9. a) Fees shall be paid in advance for all the three Degrees Rs 10,000-00 b) Joining from any Lodge under any Constitution Rs 10,000-00 c) Subscription from Resident members (per month) Payable in advance. Rs 350-00 d) Subscription from Non-Resident Members, and Resident Members in Absent list per month Rs. 180-00 e) In addition to the above, Resident Members, Non-Resident Members & Resident Members in Absent List will pay Grand Lodge and Regional Grand Lodge dues, as specified from time to time, in advance, in lumpsum. f) In addition to the above, an Initiate shall pay Rs. 10000.00 towards corpus of Charitable trust. Rs 10,000-00

13 Monthly subscription paid by the Members as well as other monies not otherwise specifically allocated shall be credited to the General Fund. Payment from the Fund except for routine purposes can be made only by resolution of the Lodge. Out of the monthly subscription of Rs.250.00 paid by every Resident Member, a sum of Rs.110.00 shall, however, be credited to the Stewards' Fund and Rs.60.00 shall be credited to the Benevolent Fund. Out of the monthly subscription of Rs.120.00 paid by Non-Resident and Resident Absentee Members, a sum of Rs.40.00 shall be credited to the Benevolent Fund. Other than this, the Lodge can transfer funds to the Benevolent Fund / Stewards' Fund by resolution of the Lodge.	13 Monthly subscription paid by the Members as well as other monies not otherwise specifically allocated shall be credited to the General Fund. Payment from the Fund except for routine purposes can be made only by resolution of the Lodge. Out of the monthly subscription of Rs.350.00 paid by every Resident Member, a sum of Rs.200.00 shall, however, be credited to the Stewards' Fund and Rs.80.00 shall be credited to the Benevolent Fund.
