Existing By-Laws	Amended By-Laws
By-Law No. <u>1,3,9</u> 1) The Regular Convocations of the chapter shall be held at the Freemason's Hall, Madras, on the first Tuesday in January, March, July, September and November, at such hour as the principals may fix. 2) The principals and the Treasure shall be elected at the Regular Convocation in November and it shall be in order for the Chapter on the day of election to resolve that the other officers may be appointed by the principals so elected. The Junior however may be elected by show of hands. They shall be installed at the next Regular Convocation in January. 3) The Audit Committee shall consist of two members of the Chapter who shall be elected annually at the Regular Convocation in November.	By-Law No. <u>1,3,9</u> 1) The Regular Convocations of the chapter shall be held at the Freemason's Hall, No. 14, Ethiraj Salai, Egmore, Chennai - 600008, on the first Tuesday in January, April, July, and October, at such hour as the principals may fix. Explanation: Due to lack of attendance at the Regular Convocations and increase in Hall rent, postage, printing charges etc. The number of Convocations reduced from FIVE to FOUR observed as most of the city chapters have only four Convocations per year. 2) The three principals and the Treasure shall be elected at the Regular (Election) Convocation in October and it shall be in order for the Chapter on the day of election to resolve that the other officers may be appointed by the principals so elected. The Junior however may be elected by show of hands. They shall be installed at the next Regular (Installation) Convocation in January. 3) The Audit Committee shall consist of two members of the Chapter who shall be elected annually at the Regular Installation Convocation in January.
