By-Law No 12 The Subscription shall be Rs. 250/- per annum for every Member payable in advance plus the annual dues to the Supreme Grand Chapter and the Regional Grand Chapter at the prevailing rate. Any Companion allowing his Subscription to remain unpaid for more than six months shall be liable to exclusion under Rule 156 B of C of the Grand Lodge.	By-Law No 12 The Subscripton shall be Rs. 350/- per annum for every Member payable in advance plus the annual dues to the Supreme Grand Chapter and the Regional Grand Chapter at the prevailing rate. Any Member allowing his Subscription to remain unpaid for more than twelve months shall be liable to exclusion under rule 156 b of C of the Grand Lodge.
