Fees and Subscriptions <p>6. Initiation including Passing and Raising ... Rs. 1500 Joining from the Indian Constitution ... Rs. 500 Joining from a recognized Constitution ... Rs. 600 Rejoining ... Rs. 500 Founder and resident members, quarterly... Rs. 250 Absentee member, Quarterly ... Rs. 100</p> <p>In addition each Founder, Resident and Absentee member shall pay an Annual Fee to cover the Grand Lodge and Regional Grand Lodge fees payable on account of his membership in this lodge. Out of Rs. 250 quarterly subscription of Resident Members, Rs. 200 shall be credited to Stewards Fund and Rs. 50 to Charity Fund. Also out of Rs. 100 quarterly subscription of Absent Members, Rs. 50 shall be credited to Charity Fund. The Services of the Secretary and the Tyler if a serving Brother or the Lodge by resolution so decide, shall be regarded as equivalent to their appropriate subscriptions to the Lodge. Should an Absentee member attend the Lodge or Banquet, he shall be charged the full subscription of Rs. 250 for that quarter.</p>	Fees and Subscriptions <p>6. Rs. 400</p> <p>In addition each Resident and Absentee member shall pay an Annual Fee to cover the Grand Lodge and Regional Grand Lodge fees payable on account of his membership in this lodge. Out of Rs. 2000 annual subscription of Resident Members, Rs. 1600 shall be credited to Stewards Fund, Rs. 200 to Charity Fund and the balance to the General Fund. Also out of Rs. 400 annual subscription of Absentee Members, Rs. 200 shall be credited to Charity Fund and the balance to the General Fund. The Services of the Secretary and the Tyler if a serving Brother or the Lodge by resolution so decide, shall be regarded as equivalent to their appropriate subscriptions to the Lodge. Should an Absentee member attend the Lodge or Banquet, he shall be charged an additional Rs. 400, being equivalent to the Stewards fund for that quarter.</p>
Funds <p>7. The Lodge shall have three funds, (a) General Fund, (b) Stewards Fund and (c) Charity Fund</p> <p>a) General Fund – Fees and subscriptions shall be credited to this fund and all administrative and other expenses and fees paid to the Grand Lodge and Regional Grand Lodge shall be debited to this Fund.</p> <p>b) Stewards Fund – This Fund shall be maintained by a transfer of Rs. 150 from monthly subscription of Rs. 250 of each Founder and Resident member. Members inviting guests shall pay for their guests as such charges as may from time to time, be fixed by the Lodge. All expenses on refreshments, etc. shall be paid for from this Fund and no part of the General Fund shall be utilized to meet the cost of refreshments.</p> <p>c) Charity Fund – The Fund shall be maintained by a transfer of Rs. 50 from the monthly subscription of each Founder, Resident and Absentee member, by collections made at Lodge meetings and by voluntary contributions from members and others. A sum of Rs. 2500 may however be annually held at the disposal of the Master to meet emergency cases of distress. Disbursements made by the Master shall be reported to the Lodge at the next regular meeting held after such disbursements.</p>	Funds <p>7. The Lodge shall have three funds, (a) General Fund, (b) Stewards Fund and (c) Charity Fund</p> <p>a) General Fund – Fees and subscriptions shall be credited to this fund and all administrative and other expenses and fees paid to the Grand Lodge and Regional Grand Lodge shall be debited to this Fund.</p> <p>b) Stewards Fund – This Fund shall be maintained by a transfer of Rs. 1600 from annual subscription of Rs. 2000 of each Resident and Joining member. Members inviting guests shall pay for their guests as such charges as may from time to time, be fixed by the Lodge. All expenses on refreshments, etc. shall be paid for from this Fund and no part of the General Fund shall be utilized to meet the cost of refreshments.</p> <p>c) Charity Fund – The Fund shall be maintained by a transfer of Rs. 200 from the annual subscription of each Resident, Joining and Absentee member, by collections made at Lodge meetings and by voluntary contributions from members and others. A sum of Rs. 5000 may however be annually held at the disposal of the Master to meet emergency cases of distress. Disbursements made by the Master shall be reported to the Lodge at the next regular meeting held after such disbursements.</p>

The above amendments were regularly Proposed and Seconded in open Lodge at a regular Meeting held on 13.01.09, Passed at a regular Meeting held on 14.04.09 and confirmed at a regular Meeting held on 14.07.09.






