BYE-LAWS
OF
CHAPTER EUREKA
No. 6 GCI

1. Regular Convocation

The Regular Convocation of the Chapter shall be held at Freemasons' Hall, Bangalore, on the third Friday in April, June, October and December and on the Fourth Friday in February and August, at such hour as the three Principals may appoint.

2. Election of Officers

The Three Principals and other Officers of the Chapter shall be elected annually at the Regular Convocation in February. The mode of election shall be by ballot, for the Office of First Principal in the first instance and the Officers in succession;

Provided that by a resolution of the Chapter duly proposed and carried in that Election Meeting, save in the case of the Treasurer and Janitor, the Three Principals may be empowered to appoint the other Officers of the Chapter, for that Year, instead of the same being elected by ballot. The Officers shall be invested and inducted at the next Regular Convocation. The Janitor may be elected by a show of hands.

3. Bye-Law No. 3

Fees :

- A. Members shall be required to pay
- i) Chapter subscription of Rs. 150/- per year, out of which Rs. 30/- per year shall be transferred to BENEVOLENT FUND.

Plus

- ii) Contribution to Stewards Fund of Rs. 150/- per year.

Plus

- iii) Regional Grand Chapter & Supreme Grand Chapter dues at actuals as applicable and payable.

B. All dues as indicated above shall become payable in full during the month of April each year or in the month of exaltation/joining.

C. Fees for Exaltation/Joining shall be as follows :-

- i) For Exaltation including Registering and certificates — Rs. 500/-
- ii) For Joining from Indian Constitution — Rs. 200/-
- iii) For Joining from other Constitutions — Rs. 350/-

- D. There shall be only one category of membership called "MEMBERS"
- E. The Scribe 'E' and Janitor shall be exempted from payment of Chapter subscription. However, they shall pay the Stewards Fund contribution and also Regional Grand Chapter & Supreme Grand Chapter dues as applicable.
- F. The Chapter subscription shall be reviewed once every THREE years and will become effective after being approved by the Supreme Grand Chapter.
- G. The Stewards Fund contributions shall be reviewed by the permanent committee every year and shall become effective from April of that year.

4. Permanent Committee

The permanent committee shall consist of the Three Principals, Past First Principals, Scribe, E., Treasurer and two companions elected on the Installation Day. The First Principal, shall be the Chairman of the Committee.

5. Audit Committee

A Committee shall be appointed annually at the February Convocation to audit the Treasurer's accounts and report thereon at the installation Convocation.

6. Alteration of Bye-Laws

No resolution or alteration, in or addition to these Bye-Laws shall be introduced or discussed in the Chapter
