<p>By-Law No.</p> <p>MEMBERS.</p> <p>1. The Lodge shall consist of Resident and Non-Resident Members.</p> <p>a) Resident Members are those who are residing within a radius of 15 miles from the limits of Bangalore City Corporation.</p> <p>b) Non-Resident Members are those who are not residing within the area stated above.</p> <p>DAYS OF MEETING</p> <p>2. The regular meeting shall be held on the Second Friday in the months of January, April, July and October at Freemasons Hall, B'lore</p> <p>ELECTION</p> <p>3. The Annual Election of the W.C.N Treasurer and warder shall be held on the day of the Regular Meeting in the month of October.</p> <p>INSTALLATION.</p> <p>4. The WCN elect shall be installed at the next Regular Meeting held in the month of January.</p> <p>TREASURER</p> <p>5. All payments exceeding Rs.20-00 shall ordinarily be paid by cheque only. The Lodge money shall be deposited in such Bank as the Lodge may from time to time direct. The W.C.N. and Treasurer shall jointly operate the account.</p>	<p>By-Law No.</p> <p>MEMBERS</p> <p>1. Members of the Lodge will generally be residents of the Metropolitan Area of Bangalore.</p> <p>Those residing outside this territory will be equally be eligible. It shall not be competent for the Brethren to abrogate, amend or alter these By-laws unless the abrogation shall have been duly proposed and passed at one regular meeting, after insertion in the summons and read and confirmed at the next Regular Meeting of the Lodge.
