**Sub: Notice of Cessation under Rule 124 – unpaid dues - reg**

Fraternal Greetings from Lodge Engineers No. 336.

From the Lodge records, it is seen that you have pending dues to the Lodge of **Rs. 11,554/-** (subscriptions + GLI & RGL dues) representing payments that have been overdue for over a year.

### **Rule 124 of the Book of Constitutions:**

*"Should the subscription of a member of any Lodge remain unpaid for one full year, at the expiration of the period, he shall cease to be a member of all Lodges, provided such a member has been duly served with a notice by Registered post with acknowledgement-due of being in arrears of the subscription amount and the member fails to make payment within 30 days of receipt of the notice. A copy of such notice shall also be sent to the Regional Grand Secretary. The fact of cessation shall be reported to the Lodge at the next regular meeting and recorded in the minutes and shall be forthwith notified to the Grand Secretary."*
