SUB: REQUEST FOR WAIVER OF HALF-YEARLY DUES FOR 31-12-2016

I am forwarding herewith a copy of letter dt.1st September, 2017 addressed to me by W Bro.Dr.Rajesh Mahadevan, W Master of Lodge Sir Visveswaraya No.450 which is self-explanatory requesting waiver of Half-yearly dues payable by the Lodge to Grand Lodge of India and Regional Grand Lodge of Southern India stating that the Lodge was Consecrated on 28th December, 2016 and was functioned as a Lodge for 4 days only during the half-year ended 31-12-2016.

Further, I am to inform you that at the meeting of the Regional Board of General Purposes of the Regional Grand Lodge of Southern India held at Kottayam on 12th February, 2017, the RGL Board considered the request received from V W Bro.T.Seetharaman, Org Secretary, on behalf of the following 7 new Lodges viz. Lodges Siddaganga No.445, Silk City No.446, Sir M Visveswaraya No.450, Viluppuram No.447, Deepak No.448, Mark and R.A.M.lodge Athalia No.176 which were consecrated by M W The Grand Master from 25th to 28th December,2016 and the RGL Board approved and sanctioned 50% of waiver of RGL Half-Yearly dues by Craft 5 Lodges for the half-year ended 31-12-2016 on the recommendation made by R W Bro.A.P.Chitra, O.S.M, P.Dy.G.M., I.P.R.G.M. the then R W The Regional Grand Master.

I shall thank you to kindly place the request of the Lodge for waiver of half-yearly dues payable to Grand Lodge of India by Lodges Riders No.439 and Sir M Visveswaraya No.450 before the Board of General Purposes of Grand Lodge of India at its meeting to be held on 16th September, 2017 for favourable consideration and communicate the decision taken by Grand Board on the subject.

Very Good Morning V W Bro Anurag Sahai,

This mail is further to our discussions we have had regarding the pending dues which, Lodge Sir M Visveswaraya No 450 GLI has to pay to RGL and GLI for the year ending 2016. (July to December 2016).

Sir my secretary and myself have explained to you this difficult situation, which our lodge is facing with regards to the non payment of the Half Yearly Lodge dues (July to December) 2016. We felt that the dues amount is too huge to pay, given the fact that we are a very new lodge and also most importantly that our Lodge was consecrated on 28th of December 2016 and we have been asked to pay the entire dues for the second Half (July to December) 2016, though we have only functioned as a Lodge for 4 calendar days in 2016.

I have to bring it to your notice that during the HYM at Tuticorin this August 2017, this matter was addressed with me by deputy RGM and the RGM in the presence of our respected RGL secretary. I have expressed the point of concern to them and have also told them that you were aware of the same since the time the reminders came to our lodge. I have been promised that this matter will be looked into from the RGL view point and also the matter will be referred to GLI office for suitable advise.

I have requested both the Deputy RGM and the RGM to waive off the dues since it is only for 4 days or we are prepared to pay retrospective for one month (December 2016 only). I will also need directives from the GLI on the same.

I kindly request you to do the needful and advise me at the earliest to resolve the matter and clear our Lodge name Sir M V 450 from the defaulter list.

Sir, as you aware that i have served masonry for the past 25 years and have just become the IPM of Lodge Thirunal No 179. Having taken the lead role to become the founder master of Sir M V 450 I have made in roads in Kolar and neighboring districts like Hoskote and Chintamani and by Gods grace along with the cooperation of a few brethren of our Lodge, and your timely guidance I am happy to say that we have initiated 9 brethren so far (7 meetings) and have raised 5 brethren. (2 FC and 2 EA), i hope to gather a good number of more Gentlemen into this Lodge before i hand over to my successor in November/December 2017.

As you are aware the plan of starting a temple at Kolar is still on. Due to the unfortunate demise of our dear R W Bro Ujjval Joshi, i have decided to take on the task of going ahead and doing my best to fulfill his dream of having the temple at Kolar. The paper work for the same will start soon and i shall keep you in the loop.

I shall await for your instructions and advise on the above matter.
