' SHOULD THE SUBSCRIPTION OF A MEMBER OF ANY LODGE REMAIN UNPAID FOR ONE FULL YEAR AT THE EXPIRATION OF THE PERIOD HE SHALL CEASE TO BE A MEMBER OF ALL LODGES, PROVIDED SUCH MEMBER, HAS BEEN DULY SERVED WITH A NOTICE BY REGISTERED POST WITH ACK DUE OF BEING IN ARREARS OF THE SUBSCRIPTION AMOUNT AND THE MEMBER FAILS TO MAKE PAYMENT WITHIN 30 DAYS OF RECEIPT OF THE NOTICE. A COPY OF SUCH NOTICE SHALL ALSO BE SENT TO THE REGIONAL SECRETARY '.

I also wish to inform you that irrespective of receipt or otherwise of the subscription from its members, it is mandatory on the part of the lodge to pay members' part of subscription to the Grand Lodge of India as well as the Regional Grand Lodge of Southern India which is quite a heavy financial burden for the lodge

I shall, therefore, be obliged, if you would please pay your dues within the stipulated period. Failure to do so, the Lodge would reluctantly apply the above rule and thereby the lodge.

I shall be obliged for your early and positive response.
