NOTICE UNDER RULE 156 OF THE BOOK OF CONSTITUTION

In continuation of the letter dated 24<sup>th</sup> January, 2018 and your reply thereof, I am to state as follows.

Your consolidated reply sent by e-mail dated 8<sup>th</sup> February, 2018 at 17:24 hrs IST was placed before the meeting of the Lodge held on 10<sup>th</sup> February, 2018, when Item No.8 of the Agenda in the Summons was taken up. Thereafter, the Resolution was put to vote by secret ballot. The Resolution was carried by 35 votes for and none against except in the case of V. W. Bro. Jyothirlingan Gowd Patil and W. Bro. T. Sathyanarayana, where the ballot was 34 for the Resolution.

All of you therefore stand excluded from the Lodge under Rule 156 of the Book of Constitution with effect from 10/02/2018.

All or any of you may file a complaint against the exclusion before the Regional Grand Master of the RGL of Southern India within ninety days from 10/02/2018 under Rule 157 (a) and (b) of the Book of Constitution, if you so desire.
